A. Schedule to Conditions of Entry

3. Contest Period:	The Contest starts at 22:00:00 on 23/12/2022 and ends at 23:59:59 on 29/12/2022.
	The Organiser reserves the right to end the Contest earlier or extend the Contest Period at its own discretion.
4. Eligibility:	1. This Contest is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Contest Period, and with a valid identification document and residential address in Malaysia.
	2. The Organiser shall reserve the right to request for evidence of identification documents.
	3. Employees of the Organiser, their immediate families, affiliates, subsidiaries, related agencies and suppliers and/or persons living in the same household are ineligible to join the Contest.
5. Entry Method:	To participate in the contest, participants are required to have a registered Instagram account with their privacy setting set to "Public".

3. Eligibility
