### TERMS AND CONDITIONS

#### **A. Schedule to Conditions of Entry**

1. <b><u>Organiser:</u></b>	GERBANG ALAF RESTAURANTS SDN. BHD (Company No.: 198001011565 (65351-M)) (“McDonald’s Malaysia”)
2. <b><u>Contest:</u></b>	#McDDoDaDipChallenge
3. <b><u>Contest Period:</u></b>	The Contest starts at 10:00:00 on 15/05/2023 and ends at 23:59:59 on 26/05/2023. (12 Days only) The Organiser reserves the right to end the Contest earlier or extend the Contest Period at its own discretion.
4. <b><u>Eligibility:</u></b>	<ol style="list-style-type: none"><li>1. This Contest is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Contest Period, and with a valid identification document and residential address in Malaysia.</li><li>2. The Organiser shall reserve the right to request for evidence of identification documents.</li><li>3. Employees of McDonald’s Malaysia, their immediate families, affiliates, subsidiaries, related agencies and suppliers and/or persons living in the same household are ineligible to join the Contest.</li></ol>
5. <b><u>Entry(ies) Method:</u></b>	<ol style="list-style-type: none"><li>1. To participate in the contest, participants must have a registered account on TikTok and must set their privacy to “Public”.</li><li>2. Incomplete entry or entries that do not adhere to the rules and deadline will automatically be disqualified.</li><li>3. The Organiser shall have the absolute discretion to select winners with the most creative submissions. Eligible winners will be awarded a prize.</li><li>4. The Organiser’s decision on the winners list is final. No further correspondence or appeal will be entertained.</li></ol>
6. <b><u>Contest Deadline:</u></b>	<ol style="list-style-type: none"><li>1. All Entries must be received by the Organiser on or before 23:59:59 on 26/05/2023.</li><li>2. All Entries received outside the Contest Period will be automatically disqualified.</li></ol>

The Conditions of Entry and the Schedule to Condition of Entry shall collectively be referred to as the "Terms and Conditions". Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Entry. Defined terms will be used singular or plural as the case may be.
- 1.2 The Organiser reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Contest Period, make Prize substitutions, cancel, terminate or suspend the Contest in whole or in part. - 2.3 Proof of submission of an Entry is not proof of receipt, and the Organiser shall not be liable for any delay, lost, damaged and/or non-receipt of submissions. The Organiser is not responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction, unauthorized access to, or alteration of, user or member communications, or any problems or technical malfunction of our

### **3. Eligibility**

- 3.1 Where the eligibility age prescribed in the Schedule to Conditions of Entry is below the age of eighteen (18), Participants are required to obtain the written consent (in such form as may be prescribed by the Organiser), from their parents/legal guardians before participating in the Contest and submitting any personal information.

- 5.2 In addition, the Organiser reserves the right to disqualify any Participant that:
- (a) undermines, has or attempted to undermine the operation of the Contest by fraud, cheating or deception; and/or
  - (b) are not eligible or unable to provide proof of eligibility to participate in the Contest for verification by Organiser when requested.
- 5.3 In the event of a disqualification after a Prize has been awarded, the Organiser reserves the right to demand for the return of the Prize or payment of its value from the disqualified Participant.

compensation to the Participant and the Participant waives all rights he or she may have in such materials or works.

## **9. Indemnity**

Each Participant agrees to indemnify, release and hold harmless each of the Organiser, its holding, subsidiary or related companies as defined in the Companies Act 2016 (“Gerbang Alaf Restaurants Sdn Bhd”), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant’s participation in the Contest, acceptance of any Prize, and/or the use of the Participant’s entry and/or likeness in connection with the Contest or violation of the Terms and Conditions,

## **10. Limitation of Liability**
