A. Schedule to Conditions of Entry

1. <u>Organizer:</u>	GERBANG ALAF RESTAURANTS SDN. BHD (Company No. 198001011565 (65351-M)) ("McDonald's Malaysia")
2. <u>Activation:</u>	McDonald's® “SPEND MORE, GET MORE” ACTIVATION
3. <u>Activation Period:</u>	The Activation starts at 00:00:00 on 31/03/2025 and ends at 23:59:59 on 14/04/2025. The Organizer reserves the right to end the Activation earlier or extend the Activation Period at its own discretion.
4. <u>Eligibility:</u>	a) This Activation is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Activation Period, and with a valid identification document and residential address in Malaysia. b) The Organizer shall reserve the right to request evidence of identification documents. c) Employees of McDonald's Malaysia, their immediate families, affiliates, subsidiaries, related agencies, and suppliers and/or persons living in the same household are ineligible to win the Prize(s).
5. <u>Activation Mechanism:</u>	a) To be qualified in this Activation: i. Customers must make a minimum purchase of RM28.00 (inclusive of Tax) in a single receipt. ii. B. Conditions of Entry

1. Introduction

- 1.1 These Conditions of Entry are to be read together with the Schedule to Conditions of Entry. To the extent that there is any inconsistency between these conditions of entry and the Schedule to Conditions of Entry, the Schedule to Conditions of Entry prevails. The Conditions of Entry and the Schedule to Condition of Entry shall collectively be referred to as the “Terms and Conditions”. Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Entry. Defined terms will be used singular or plural as the case may be.
- 1.2 The Organizer reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Activation Period, make Prize substitutions, cancel, terminate or suspend the Activation in whole or in part. In the event of any changes to the Terms and Conditions, Participants agree that their continued participation in the Activation will constitute their acceptance of the Terms and Conditions (as changed).
- 1.3 The Organizer’s decision on all matters relating to the Activation including judging and selection of winners will be final, binding, and conclusive on all Participants, and no correspondence or appeals will be entertained.

2. Activation Entries

- 2.1 By participating or submitting an entry to the Activation, Participants are deemed to have understood and agreed to be bound by the Terms and Conditions.
- 2.2 All costs and expenses incurred and/or arising from the participation in the Activation, including without limitation, telecommunications, network, Short Messaging Services, postal and all such other charges and out-of-pocket expenses as may be incurred by a Participant during or in connection with the Activation shall be borne by the Participant.
- 2.3 Proof of submission of an Entry is not proof of receipt, and the Organizer shall not be liable for any delay, lost, damaged and/or non-receipt of submissions. The Organizer is not responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction, unauthorized access to, or alteration of, user or member communications, or any problems or technical malfunction of our telecommunications network or lines, computer online systems, servers or providers, computer equipment, software, failure of e-mail or players on account of technical problems or traffic congestion on the Internet.

3. Eligibility

- 3.1 Where the eligibility age prescribed in the Schedule to Conditions of Entry is below the age of eighteen (18), Participants are required to obtain the written consent (in such form as may be prescribed by the Organizer), from their parents/legal guardians before participating in the Activation and submitting any personal information.
- 3.2 The Organizer may require a Participant to provide proof of eligibility to participate in the Activation including without limitation, identification documents, and the written consent of parents/legal guardians in the case of Participants below the age of eighteen (18) years.

4. Ineligibility

- 4.1 The following groups of persons shall not be eligible to participate in the Activation:

5. Disqualification

- 5.1 The following entries will be disqualified:
- (a) unclear, incomplete, duplicate, copies, illegible or incorrect entries; and/or
 - (b) entries that violate the Terms and Conditions, any applicable laws and/or regulations.
- 5.2 In addition, the Organizer reserves the right to disqualify any Participant that:
- (a) undermines, has or attempted to undermine the operation of the Activation by fraud, cheating or deception; and/or
 - (b) are not eligible or unable to provide proof of eligibility to participate in the Activation for verification by Organizer when requested.
- 5.3 In the event of a disqualification after a Prize has been awarded, the Organizer reserves the right to demand for the return of the Prize or payment of its value from the disqualified Participant.

8.1 The Participant agrees that all intellectual property rights in any contents and/or materials submitted, made or created by the Participant in connection with the Activation and any derivative works arising there from will perpetually and unconditionally be vested in, assigned to and owned by the Organizer. The Organizer has the right to use and modify such materials or works in any way it deems fit without compensation to the Participant and the Participant waives all rights he or she may have in such materials or works.

9. Indemnity

9.1 Each Participant agrees to indemnify, release and hold harmless each of the Organizer, its holding, subsidiary or related companies as defined in the Companies Act 2016 (“Gerbang Alaf Restaurants Sdn Bhd”), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant’s participation in the **Activation**, acceptance of any Prize, and/or the use of the Participant’s entry and/or likeness in connection with the Activation or violation of the Terms and Conditions,

10. Limitation of Liability

10.1 The Participant’s participation in the Activation shall be at the Participant’s own risk.

This Activation and the Organizer are not affiliated with, or endorsed or sponsored by, the relevant owners, unless otherwise communicated, and such owners are not part of the Organizer’s group of companies

12.5 Where the Terms and Conditions of the Activation are prepared in English and any other language(s) in the event of any inconsistency between the English language and the other language(s), the English language version shall prevail and govern in all respects.

12.6 The Terms and Conditions of the **Activation** shall be construed, governed, and interpreted in accordance with the laws of Malaysia.
